The copper facilities servicing specific addresses in the Hamilton Wire Center are being retired due to a road construction project by Butler		
<b>Description of type of changes planned:</b>		
Existing copper facilities at the locations shown below will be retired. Butler County, Ohio has engaged in a road construction project that requires the relocation of CBT facilities. In conjunction with this project, CBT will retire the copper facilities at these locations and replace them with fiber-to-the-premise facilities. Butler County is beginning the road construction project in late June 2020 and thus is requiring CBT to relocate the facilities at these addresses by early June, 2020.

<b>Description of Reasonably Foreseeable Impact of the Planned Changes:</b>

After retirement of the copper facilities, CBT will (1) no longer offer services over the copper facilities; and (2) cease maintaining copper facilities. All services previously provisioned over copper facilities to affected customers will continue over fiber facilities. CBT is requesting an effective date of less than 90 days because of the time requirements of Butler County Ohio. CBT has contacted the sole interconnector's engineering group to facilitate the advanced timing of the road job, thus there should be no adverse impact of an effective date less than 90 days.
